**ORDINANCE #01 - 2015**

**AN ORDINANCE OF THE BOARD OF HEALTH OF THE  
BOROUGH OF HOPATCONG, COUNTY OF SUSSEX AND  
STATE OF NEW JERSEY AMENDING CERTAIN  
PORTIONS OF CHAPTER 251 “FEES” AND CHAPTER  
255, “FOOD HANDLING”**

**BE IT ORDAINED** by the Board of Health of the Borough of Hopatcong, in the County of Sussex and State of New Jersey that Chapter 251, “Fees” and Chapter 255, “Food Handling” of the Code of the Borough of Hopatcong are hereby amended as follows:

**SECTION I.** Chapter 251 entitled “Fees,” is hereby amended, supplemented, and revised by deleting Section 251-4(B) in its entirety and replacing same as follows:

**§251-4. Retail food licenses.**

B Fees.

VI (mobile Type E, ten-day license)	\$ 25.00

**NOTE:** Retail food license fees do not include required quarterly water samples, if well water.

**SECTION II.** Chapter 255 entitled “Food Handling,” is hereby amended, supplemented, and revised by deleting Section 255-4(B)(1) in its entirety and replacing same as follows:

**§255-4. Permit; fees; classification of establishments.**

B(1) Fees.

VI (mobile Type A, twelve-month license)	\$250.00
VI (mobile Type B, ninety-day license)	\$125.00
VI (mobile Type C, sixty-day license)	\$ 75.00
VI (mobile Type D, thirty-day license)	\$ 50.00
VI (mobile Type E, ten-day license)	\$ 25.00

NOTE: Retail food license fees do not include required quarterly water samples, if well water.

**SECTION III.** Chapter 255 entitled “Food Handling,” is hereby amended, supplemented, and revised by deleting Section 255-4(C) in its entirety and replacing same as follows:

**§255-4. Permit; fees; classification of establishments.**

(C) Permits issued or approved under the provisions of this article for Class I, II, III, IV and V shall expire annually on April 1 of each year, and application for renewal thereof shall be submitted, together with the required fee, prior to April 1 of each year. A late fee in the amount of \$25.00 per month shall be charged to each retail food-handling establishment that submits an application for renewal on or after April 1.

**SECTION IV.** If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

**SECTION V.** In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough, the provisions hereof shall be determined to govern. All other ordinances of the Borough are hereby ratified and confirmed, except where inconsistent with the terms hereof.

**SECTION VI.** This Ordinance shall take effect immediately upon final passage and publication according to law.

Ordinance will be considered for final reading and adoption at a regular meeting of the Board of Health to be held on February 4, 2015, at 7:00 p.m., or as soon thereafter as the Board of Health may hear this Ordinance at the Municipal Building, 111 River Styx Road, Hopatcong, New Jersey 07843, at which time all persons interested may appear for or against the passage of said Ordinance.
