**CAPITAL ORDINANCE PROVIDING FOR VARIOUS  
EQUIPMENT AND IMPROVEMENTS FOR THE POLICE,  
FIRE AND PUBLIC WORKS DEPARTMENTS, BY AND IN  
THE BOROUGH OF HOPATCONG, IN THE COUNTY OF  
SUSSEX, STATE OF NEW JERSEY; APPROPRIATING  
\$173,000 THEREFOR FROM THE CAPITAL  
IMPROVEMENT FUND OR CAPITAL FUND SURPLUS TO  
PAY FOR THE COST THEREOF**

**WHEREAS**, the Borough of Hopatcong, in the County of Sussex, State of New Jersey (the "Borough"), wishes to undertake various improvements for or acquire and install, as applicable, various equipment for the Borough's Police, Fire and Public Works Departments; and

**WHEREAS**, the cost of said improvements or purposes is estimated to be \$173,000; and

**WHEREAS**, the Borough desires to authorize the appropriation and expenditure of \$173,000 from the following funds of the Borough, \$128,000 from the Capital Improvement Fund and \$45,000 from Capital Fund Surplus, to undertake various improvements for or acquire and install, as applicable, various equipment for the Borough's Police, Fire and Public Works Departments.

**BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF HOPATCONG, IN THE COUNTY OF SUSSEX, STATE OF NEW JERSEY** (a majority of the full membership thereof affirmatively concurring), **AS FOLLOWS:**

**SECTION 1.** The capital improvement or purpose described below is hereby authorized as a general capital improvement to be undertaken by the Borough. For the said improvement or purpose, there is hereby appropriated the amount of \$173,000 from the following funds of the Borough, \$128,000 from the Capital Improvement Fund and \$45,000 from Capital Fund Surplus, to undertake various improvements for or acquire and install, as applicable, various equipment for the Borough's Police, Fire and Public Works Departments, including but not limited to, the acquisition and installation, as applicable, of a police vehicles and a 911 system for the Police Department, the acquisition and installation, as applicable, of radios and fire hoses for the Fire Department

and the acquisition of a plow truck for the Public Works Department and all work, materials, equipment, labor and appurtenances necessary therefor or incidental thereto.

**SECTION 2.** The expenditure of the \$173,000, consisting of appropriations of \$128,000 from the Capital Improvement Fund and \$45,000 from Capital Fund Surplus of the Borough, for the improvement or purpose set forth in Section 1 hereof is hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer and any other official/officer of the Borough are each hereby authorized and directed to execute, deliver and perform any agreement to undertake the improvement or purpose set forth herein and to effectuate the transaction contemplated hereby.

**SECTION 3.** The capital budget of the Borough is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the Office of the Clerk and is available for public inspection.

**SECTION 4.** This ordinance shall take effect immediately after final adoption and approval by the Mayor as described in N.J.S.A. 40:49-2.
