BE IT RESOLVED by the Mayor and Council of the Borough of Hopatcong, in compliance with the Open Public Meetings Act, NJSA 10:4-6 et. Seq., as follows:

1. The Mayor and Council of the Borough of Hopatcong hereby announces that it shall hold its regularly scheduled monthly meetings, its regularly scheduled agenda meetings at the Municipal Building, 111 River Styx Road, Hopatcong, N.J. 07843, at the dates listed below. The time for all meetings is 6:30 P.M. for Executive Session and 7:30 P.M. regular open session. Formal action may be taken at all meetings.
2. The newspapers to which all notices required by the aforesaid Act are to be sent: The New Jersey Herald, The New Jersey Sunday Herald.
3. The public place at which all notices shall be posted shall be the bulletin board situated in the hallway of the Municipal Building.
4. Agendas for all meetings will be placed on the Borough website – www.hopatcong.org.
5. Borough meetings to be conducted in accordance with Roberts Rules of Order, and at the discretion of the Mayor or presiding Officer.
6. Public Comment Period(s) shall provide an opportunity for each individual to speak for five (5) minutes, and when appropriate as determined by the presiding official, an extension may be granted. Members of the governing body may respond to the individual if they so chose at the conclusion of the Public Comment Period. Any and all comments should be addressed to the governing body, not to the general public and delivered in a civil and non-provocative manner. The governing body shall by motion close the public comment period by a majority vote. The Public Comment Period shall not exceed one (1) hour unless approved by a majority vote of the governing body.
